



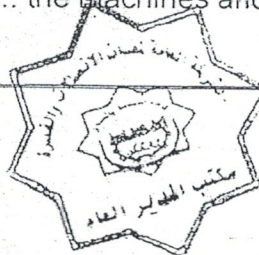

- 8- The contract is subject to Iraqi laws and legislation to resolve the dispute and the Iraqi judiciary is competent to consider it.
